

Cabela's Gift Card Contest Official Rules

1. No purchase necessary to enter or win. The Cabela's Gift Card Contest ("Contest") is sponsored by Wellmark International ("Wellmark"). The Contest begins on January 1, 2010 and ends on June 1, 2010. Online entries must be submitted by June 1, 2010 midnight (CST); mailed-in entries must be postmarked by June 1, 2010 and received by Wellmark by June 7, 2010. Only one entry per entrant allowed. Entry by any type of robotic, programmed or automatic submission is prohibited. All eligible entries will be entered in the Contest. Incomplete entries will not be accepted. Entries are subject to verification. Submissions may be investigated and voided if fraudulent. Affidavits may be required to confirm eligibility. Online entrants must have internet access as of January 1, 2010.
